

VALIDATE: Membership Terms & Conditions, and Code of Conduct

Please read the terms and conditions below. By becoming a VALIDATE member, you accept these terms and conditions and agree always to act in accordance with them.

VALIDATE takes members breaking these membership terms and conditions very seriously, and doing so may result in your permanent expulsion from the VALIDATE network. If you do not agree to these terms, please do not register as a member.

If you have any concerns about these membership terms and conditions please contact the Network Management Team (validate@ndm.ox.ac.uk) before completing your registration.

1. Membership

- a) By completing and submitting the Membership Application form (available on the VALIDATE website) to VALIDATE you will become a member of VALIDATE.
- b) Your membership level will be assessed and decided by the Management Team and Network Management Board; levels are described on the VALIDATE website. You can apply to move between membership levels as you gain experience and expertise by resubmitting the Membership Application form.
- c) By completing and submitting the 'Biography page for VALIDATE website' section of the Membership Application form you agree to being listed on the VALIDATE website as a member, using the information you provide in this section, which will then be publically available through the website. You can amend or delete your information at any time by contacting the VALIDATE team.

2. Data Collection and Privacy

We respect the privacy of all our members, and are committed to the protection of all non-public, personal information. Personal information provided to us is governed by the <u>VALIDATE Privacy</u>
<u>Notice</u>, available to view on the VALIDATE website. In addition:

- a) It is the individual member's responsibility to ensure your information is up to date and to inform the VALIDATE team of any changes. If you wish to amend your personal information you can do so at any time by completing the membership update form, available on the VALIDATE website.
- b) You can unsubscribe from the VALIDATE mailing list, and/or terminate your VALIDATE membership at any time by contacting the VALIDATE team.
- c) If the email address you provide during the registration process becomes invalid and emails sent to you by the VALIDATE team result in a Delivery Notification Status (failure) response, your membership will be considered to have lapsed and will be cancelled, and your details will be deleted from the directory of members.

3. Member's conduct

- a) Members of VALIDATE are expected to comport themselves in accordance with the general principles of good research practices, having:
 - i. Reliability in ensuring the quality of research, reflected in the design, the methodology, the analysis and the use of resources

- ii. Honesty in developing, undertaking, reviewing, reporting and communicating research in a transparent, fair, full and unbiased way
- iii. Respect for colleagues, research participants, society, ecosystems, cultural heritage and the environment
- iv. Accountability for the research from idea to publication, for its management and organisation, for training, supervision and mentoring, and for its wider impacts
- v. Integrity in the work they present as their own, and in providing adequate credit when referencing the work of others
- b) Members agree to treat all other VALIDATE members, no matter their level of seniority or membership level within VALIDATE, with respect and courtesy.
- c) Membership of VALIDATE is with a view to furthering the aims and vision of the VALIDATE Network. You do not have permission to use contact details obtained from the members' directory to send unsolicited emails for the purpose of direct marketing.
- d) Members may have access to unpublished data at VALIDATE events or via the VALIDATE Hub. As a member you agree to respect the confidentiality of these data at all times. Postings made in the VALIDATE Hub or at VALIDATE events should be treated as confidential and must not be disseminated unless already in the public domain.
- e) You must not share your unique VALIDATE Hub login details with any other person and you must take immediate steps to change your login details if you suspect that another person is using them to gain access to the secure area.
- f) In the event that you share data in the portal or provide content for the website, such content will not be used for the transmission, uploading or posting of any computer viruses or any other harmful or deleterious files or programs.
- g) All human data shared to the portal or with other VALIDATE members must be anonymised.
- h) All partners in any research collaboration formed through VALIDATE will ensure all partners in the collaboration are properly informed and consulted about all submissions for publication of research results.
- i) Members agree to abide by the expectations and best practices listed in the <u>VALIDATE</u> Statement on use of Artificial Intelligence (AI).

4. Attending Network Events

As a Network member you will have the right to apply to attend Network workshops and events. In becoming a member you understand and agree that:

- a) Submission of an application to attend an event does not constitute confirmation that a place has been awarded to you.
- b) In the event that you are successful in your application to attend a Network event, you will receive a confirmatory email upon the award of your place followed by full attendance details which will be made available to you no less than two weeks before the event is due to take place.
- c) VALIDATE will not be held liable for any costs incurred by you.
- d) Members awarded a place at an event are expected to inform VALIDATE as soon as possible, and in good time ahead of the event, if they can no longer attend.

5. The VALIDATE Website

- a) Any material displayed on the website is provided without any guarantees, conditions or warranties as to its accuracy. Your use of the website and its contents is at your own risk.

6. Burkholderia pseudomallei Resources

Burkholderia pseudomallei is listed as a controlled pathogen under the laws of the United Kingdom. As VALIDATE is based at the University of Oxford (as well as Stellenbosch University), we are required to abide by the export control restrictions of the UK when transferring any resources related to Burkholderia pseudomallei to our members internationally.

Any transfers of *Burkholderia pseudomallei* resources obtained through membership of VALIDATE are not permitted. A non-exhaustive list of potential re-export scenarios which should be avoided include:

- a) Downloading and sharing resources from the VALIDATE Hub with other people.
 - i. If another researcher needs to view a resource, they should become a member of VALIDATE to be able to access it themselves.
- b) Sharing your login credentials to the VALIDATE Hub.
- c) Taking pictures and videos of unpublished data at VALIDATE events both in-person and online
- d) Accessing controlled resources while you are in a country that is not the one your institution is based in.
 - i. You should avoid accessing *Burkholderia pseudomallei* resources while travelling*.

*With regards to the restriction on out-of-country accessing of *Burkholderia pseudomallei* resources: if you will be travelling out of your home country and know in advance that you will need to access a controlled resource ahead of time (e.g. a seminar on *Burkholderia pseudomallei* is scheduled to take place while you are abroad on a work trip), do contact the VALIDATE Team for advice, as we will be able to advise whether the country you will be accessing from is covered by our licenses or not, and whether the access can take place.

7. Updates to terms and conditions

We will post a notification of any changes to the terms and conditions of membership on the VALIDATE website and notify you by email. You have the option to terminate your membership if you do not agree with future changes to terms and conditions.
